**EARLY BIRD ON-LINE ENROLLMENT OPTIONS:** 2023 rates are in effect through December 30, 2024. **SPECIAL EARLY BIRD:** Enroll By October 20, 2024, and receive a reduction of \$10 per week. 2025 rates apply to enrollments beginning January 1, 2025. After May 1, 2025, any reduction in weeks will have a surcharge of \$50.

- Payments online can be paid by credit card (approximate 3% fee), ACH, or personal checks (mail) or cash (at camp).
- Checks will be issued on the last day of camp for any credits to campers' accounts.

**Weeks added to the initial early bird enrollment will be at the regular Early Bird tuition excluding the bonus. 2025 rates will apply for a reduction in weeks after April 30, 2025.**

**Vacation plans uncertain? Sign up for fewer weeks then add at a later time to avoid any penalties.**

As per our terms, there will be no refunds, transfer of funds, etc., for days not attended. Additional weeks can always be added at no charge, pending availability.

***ENROLLMENT PROCEDURE, TERMS, AND CONDITIONS***

- Complete the online registration select a payment method, or make your check payable to "**Winnwald Day Camp.**" A convenience fee of approximately 3% will be added to Credit Card transactions.
- Any enrollment changes must be requested in writing via e-mail to [winnewald@gmail.com](mailto:winnewald@gmail.com)
- Outstanding balances will be charged to the account on file the last day of camp unless previous arrangements have been made.
- **May 1, 2025 for Early Bird enrollment**
  - Early Bird balances are due. Failure to pay by due date will result in 2025 rates.
  - **A reduction in the number of weeks** enrolled will result in 2025 rates **plus a \$50 administrative fee.**
- **June 1, 2025, and after**
  - **All balances** must be **paid IN FULL** prior to the opening of camp.
  - Payments are made online; paper checks should be mailed to the camp.
  - NO refunds or transfer of funds will be made for schedule changes, withdrawal, dismissal, days absent, missed days, or incomplete attendance. *There are **no make-up days** for any days missed.*
  - Registration is not complete until **ALL** online forms have been submitted.
  - A 2 percent per month carrying charge or \$4 minimum will be applied to past-due balances after of June 15.
  - Evening activity fees are due upon registration for the activity; dates will be posted at a later time.
  - Campers unable to fulfill their campership due to a **doctor-certified illness** will receive a partial credit for the following season. The doctor's note (on his/her letterhead) must state reason, days missed due to illness, and doctor's signature.
  - A charge of \$25 will be levied for any checks returned due to insufficient funds.
- **No camper will be permitted in camp without:**
  - (1) Without a completed online registration (all forms – health, immunization, allergy, etc.) and
  - (2) Balance paid in full or with a payment plan schedule on Campium.

**For Campers with an IEP, 504, or Medical Management Plan**

- If the child has an IEP, a 504-accommodation plan, or a Medical Management Plan, final acceptance into camp will be made pending review of these documents and a personal interview - submission of these documents is part of the registration process. Registration should be completed 4 weeks prior to the beginning of the camper’s enrollment.
- A personal interview will be scheduled with the parent and prospective camper.
- Completion of the Medical Management Plan Form and Release Form, if necessary.
